

**RESOLUTION OF THE BOARD OF TRUSTEES OF THE UTAH TRANSIT
AUTHORIZING THE ADOPTION OF VANPOOL RATES**

WHEREAS, Utah Transit Authority (the “Authority”) is a large public transit district organized under the laws of the State of Utah, created to transact and exercise all of the powers in the Utah Limited Purpose Local Government Entities – Special Districts Act and the Utah Public Transit District Act; and

WHEREAS, the Board of Trustees (the “Board”) is entrusted with supervising and regulating the rates, rentals and charges enacted by the Authority pursuant to Utah Code §17B-2a-808.1(2)(k); and

WHEREAS, the Authority offers transit service under its vanpool program (“Vanpool”) through which individuals and companies use UTA vehicles for commuter activities, thereby reducing traffic congestion and air pollution; and

WHEREAS, the Board desires to review and update the rates and charges of Vanpool (“Rates”) to account for ridership needs, inflation, and market conditions; and

WHEREAS, the Board has reviewed the updated Rates enumerated in Exhibits A thru C, governing Vanpool Fixed Rates, Vanpool Corporate Rates, and Other Rideshare Rates, respectively; and

WHEREAS, the Board finds the Rates to be reasonable, equitable and necessary for the orderly and prudent operations of the Authority, and in the public’s interest.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Utah Transit Authority:

1. That the Board hereby adopts the Vanpool Fixed Rate Price Per Seat in Exhibit A.
2. That the Board hereby adopts the Vanpool Corporate Rates in Exhibit B.
3. That the Board hereby adopts the Other Rideshare Rates in Exhibit C.
4. That the effective date for rates established in Exhibits A thru C shall be December 1, 2024.

5. That the Board formally ratifies actions taken by the Authority, including those taken by the Executive Director, staff, and counsel, that are necessary or appropriate to give effect to this Resolution.

6. That the corporate seal be attached hereto.


